Introduction

This Privacy Notice explains in detail the types of personal data we may collect about you when you interact with us. It also explains how we'll store and handle that data, and keep it safe.

This information is provided because Data Protection Law gives individuals rights to understand how their data is used.

What is Woodhouse Grove School Enterprises?

Woodhouse Grove Enterprises limited is a wholly owned subsidiary of the Methodist Independent Schools Trust (Company No: 7649422, Charity No: 1142794). The company is principally engaged in commercial trading activities relating to and in support of the charitable activities of Woodhouse Grove School.

Explaining the legal bases we rely on

The law on data protection sets out a number of different reasons for which a company may collect and process your personal data, including:

Legitimate Interest.

In specific situations, we require your data to pursue our legitimate interests in a way which might reasonably be expected as part of running our business and which does not materially impact your rights, freedom or interests.

When do we collect your personal data

• We request your data at enquiry stage for a booking or rental of our facilities.

What sort of personal data do we collect?

 We collect all the data that we need to complete a booking form, this could be company data or individual data if it is a personal booking.

How and why do we use your personal data?

 To process any booking. If we don't collect your personal data during the booking process, we won't be able to fulfil the booking and comply with our legal obligations.

- To respond to your queries and complaints. Handling the information you sent enables us to respond. We may also keep a record of these to inform you of any future communication with us and to demonstrate how we communicated with you throughout. We do this on the basis of our contractual obligations to you, our legal obligations and our legitimate interests in providing you with the best service and understanding how we can improve our service based on your experience.
- To manage your booking all data is held within our electronic booking system.
- The data is also used to produce invoices for the booking.

How we protect your personal data

We know how much data security matters to all our customers. With this in mind we will treat your data with the utmost care and take all appropriate steps to protect it.

The school will take appropriate technical and organisational steps to ensure the security of personal data including policies around use of technology and devices, and access to school systems.

How long we keep personal data

Whenever we collect or process your personal data, we'll only keep it for as long as is necessary for the purpose for which it was collected.

At the end of the booking/hire period, your data will be stored so we can communicate with you about future opportunities of the same purpose as your original booking.

Who has access to personal data and who the school shares it with

Occasionally, the school will need to share personal information relating to its community with third parties, such as:

- professional advisers (e.g. lawyers, insurers, PR advisers and accountants);
- government authorities (e.g. HMRC, DfE, police or the local authority); and
- appropriate regulatory bodies

For the most part, personal data collected by the business will remain within the business, and will be processed by appropriate individuals only in accordance with access protocols (i.e. on a 'need to know' basis).

Where your personal data may be processed

Your Rights

You have the rights to:

The right to be informed
The right of access
The right to rectification
The right to erasure
The right to restrict processing
The right to data portability
The right to object
Rights in relation to automated decision making and profiling.

If at any point you believe the information we process on you is incorrect you can request to see this information and have it corrected or deleted. Where the business is relying on consent to process personal data, any person may withdraw this consent at any time.
