Please find the relevant information below for the October half term Ashdown Early Years Provision. The Early Years Provision will run from Monday 19th October until Friday 30th October. Parents whose children are on a 51-week contract or a term time + 8 weeks contract have already been allocated a space and need not take any further action from this letter.

Please note that children are still unable to mix between Bubbles and so places are limited. Applying for a space does not guarantee a place in the Holiday Early Years Provision, however, we will do our best to accommodate as many families as possible whilst maintaining a safe environment.

The children will receive a hot lunch and a light tea of sandwiches and crudites that will be served at 3:30pm each afternoon. Please note that the deadline for returns is Monday 5th October.



Our opening hours reflect our commitment to remaining open and providing safe and consistent care for our children. The need for children and staff to remain in consistent bubbles continues to significantly impact our staffing levels across the school, and due to this we do not have the staff numbers required to provide the extended day provision in non-term time for these two weeks. This decision has been made based on the health and wellbeing of the children and staff at this unprecedented time. We appreciate that this is not an ideal situation, but we hope you can understand why this decision has been made.

Those families currently on a 51-week contract, or on a term time plus 8 contract, who have booked places for half term, will be reimbursed £10.00 per day for these two weeks. This credit will be allocated to your fee account.

The same systems currently in place to protect children and staff against risks of COVID 19 apply to all non-term time care.
